Applications	<p>STEPANOL ME-DRY is a sodium lauryl sulfate derived from fatty alcohol sulfonated via Stepan's continuous SO_3 process. The product of this process is then spray dried to produce a white powder.</p> <p>STEPANOL ME-DRY is used in powdered bubble baths, hand cleaners, and detergents. Because of its excellent foaming properties, STEPANOL ME-DRY is used in liquid hand soaps, shampoos, and other personal care and detergent applications.</p>

Health Effects	STEPANOL ME-DRY is slightly toxic orally to mammals (LD_{50} is between 0.8 to 1.1 g/kg) and aquatic organisms (LC_{50} =12 mg/L). At 10% active, it causes moderate to severe skin and eye irritation.
Storage & Handling	<p>Normal safety precautions (e.g., gloves and safety goggles) should be employed when handling STEPANOL ME-DRY. Contact with eyes, nose or prolonged contact with skin should be avoided. Wash thoroughly after handling STEPANOL ME-DRY. Avoid inhaling dust. See SDS for more information.</p>

Standard Packaging: STEPANOL ME-DRY is available in drums quantities.

Non-Bulk Storage Recommendations: STEPANOL ME-DRY should be stored in closed containers and kept in a cool, dry place to avoid agglomeration, and should be kept away from incompatible materials (see Section 10 of the SDS).
