Procedure	1. Charge vessel with Deionized Water. Start agitation. 2. Slowly sprinkle in Carbopol ETD2020. Mix until completely dispersed. 3. Add Glycerin, STEPAN-MILD® PCL, AMPHOSOL® HCG (or AMPHOSOL® HCG-HP), and Merquat 550. Mix well. 4. Add Lipo APS 40/60 and Lipo WSF 35/60. Mix until homogeneous. 5. Adjust pH to 5.0–6.0 with Sodium Hydroxide, 50% solution or Citric Acid, 50% solution. 6. Add Preservative, Fragrance, and Dye. *Note: When formulating with AMPHOSOL® HCG-HP, a greater amount of Citric Acid, 50% solution, may be needed to adjust the pH within the recommended range as noted, than when formulating with AMPHOSOL® HCG.
