Deionized Water 58.0 Diluent STEPANATE® SXS 15.0 Hydrotrope Propylene Glycol n-Propyl Ether 6.0 Solvent AMPHOSOL® CG-50 21.0 Surfactant

Procedure

- 1. Charge Deionized Water.
- 2. With good agitation, add STEPANATE® SXS and Propylene Glycol n-Propyl Ether.
- 3. Continue to mix and add AMPHOSOL® CG-50.
- 4. Mix until homogenous.

Formulation should be diluted to 2 ounces per one gallon of water. Deviation from this dilution level can result in different VOC levels.

Gardner Straightline Washability Test, SM 250-0 (ASTM D4488-95-A5); 1:64 dilution = 56% soil removed at stroke 1, 84% soil removed at stroke 3, and 93% soil removed at stroke 10.
