Procedure

Add Oleic acid, Triethanolamine, MAKON® 10, NINOL® 11-CM, d-Limonene, and STEPOSOL® SB-W together and mix until clear. Heat to 70°C-80°C. Slowly add Deionized Water with mixing. Once dispersed, begin cooling to room temperature. A thick gel will form.
